NOTICE OF PROPOSED AMENDMENT TO THE NAPIA CONSTITUTION & BYLAWS

The following amendment, to add section 11 to Article VI of the NAPIA Constitution & Bylaws, will be presented for a vote by the membership during the 2008 Mid-Year Meeting at Disney's BoardWalk Inn at Walt Disney World in Orlando, Florida:

Section 11. No applicants for membership who are individuals, partnerships or corporations who or which are engaged in the practice of public adjusting and participate and deal in any manner or to any extent as a salvor or in building construction, repairs, restoration or mitigation (as related to first party property insurance losses), shall be permitted to be a Regular Member, Associate Member, Life Member, Affiliate Member or an Independent Contractor Member.
